Pursuant to General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 20/2020 dated May 5, 2020, General Circular No. 02/2021 dated January 13, 2021, Circular No. 02/2022 dated May 05, 2022 and Circular No.10/2022 dated December 28, 2022 and all other relevant circulars issued by the Ministry of Corporate Affairs (collectively referred to as ‘MCA Circulars’), the Company is convening the 42nd AGM physically at the registered office of the company.

I. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended) and MCA Circulars, the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the e-Voting agency. The facility of casting votes by a member using remote e-voting will be provided by CDSL.

II. In compliance with the MCA Circulars and SEBI Circular dated January 15, 2021 and May 12, 2020 respectively, the Notice of the AGM along with the Annual Report 2025-26 has been uploaded on the website of the Company at www.shreevijayg.co.in. The Notice of the Annual General Meeting along with the Annual Report for the financial year 2025-26 is being sent only by electronic mode to those Members whose email addresses are registered with the Company/Depositories. - (i) The voting period begins on Monday, September 21, 2026 (9.00 AM IST) and ends on Wednesday, September 23, 2026 (5.00 PM IST) During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of Friday, September 18th, 2026 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- (iii) Pursuant to SEBI Circular No. **SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020**, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to **all the demat account holders, by way of a single login credential, through their demat accounts/**

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

We submit herewith the “Management Discussion and Analysis Report” on the business of the Company as applicable to the extent relevant.

OBJECTIVE OF REPORT

The Objective of this report is to convey Management’s perspective on the external environment and textile industry, as well as strategy, operating and financial performance, material developments in human resources and industrial relations, internal control systems and their adequacy in the Company during the financial year 2025-26. This report should be read in conjunction with the Company’s financial statements, the schedules and notes thereto and other information included elsewhere in the Annual Report. The Company’s financial statements have been prepared in accordance with Indian Accounting Standards (‘Ind AS’) complying with the requirements of the Companies Act, 2013, (‘Act’) and regulations issued by the Securities and Exchange Board of India (‘SEBI’), each as amended from time to time.

EXTERNAL ENVIRONMENT

Global Economic Condition and Outlook:

The global economy demonstrated resilience during FY 2025-26 despite continued geopolitical tensions, elevated public debt levels, trade policy uncertainties, and uneven growth across regions. While inflationary pressures moderated in most major economies due to tighter monetary policies and easing commodity prices, economic growth remained below long-term historical averages.

According to the International Monetary Fund (IMF) World Economic Outlook Update – July 2025, global economic growth is projected at 3.0% in 2025 and 3.1% in 2026. The upward revision reflects improved financial conditions, lower effective tariff rates in certain major economies, fiscal expansion measures, and stronger-than-expected economic activity in some regions. Nevertheless, global growth continues to face downside risks arising from geopolitical conflicts, trade tensions, supply chain disruptions, and elevated uncertainty.

Advanced economies are expected to witness modest growth, supported by easing inflation and gradual normalization of monetary policies. Emerging Market and Developing Economies are projected to continue outperforming advanced economies, driven primarily by strong domestic demand, demographic advantages, and ongoing structural reforms. Emerging Asian economies, led by India and China, are expected to remain significant contributors to global growth. India continues to be among the fastest-growing major economies globally, supported by robust domestic consumption, infrastructure investments, digital transformation, and policy reforms.

Global inflation is expected to continue its downward trajectory, although price pressures remain above target levels in certain economies. Central banks across the world are maintaining a cautious approach toward monetary easing while balancing inflation control with economic growth and financial stability objectives. At the same time, high sovereign debt levels and fiscal constraints may limit the ability of governments to respond to future economic shocks.

The global outlook remains cautiously optimistic. While improving financial conditions and declining inflation provide support to economic activity, risks arising from geopolitical developments, protectionist trade measures, commodity price volatility, and financial market uncertainties continue to warrant close monitoring. The IMF has emphasized the importance of restoring confidence, maintaining price and financial stability, rebuilding fiscal buffers, and pursuing structural

reforms to support sustainable long-term growth.

Your Company continues to closely monitor global economic developments and remains focused on strengthening operational resilience, maintaining financial discipline, and pursuing sustainable growth opportunities to create long-term value for its stakeholders.

Indian Economy and Outlook:

India continues to be one of the fastest-growing major economies in the world, demonstrating remarkable resilience amid global geopolitical uncertainties, inflationary pressures, and trade disruptions. According to the latest IMF projections, India's economy is expected to grow by approximately 6.4% in both 2025 and 2026, significantly outpacing most major economies and reinforcing its position as a key driver of global growth. India continues to benefit from strong domestic consumption, rising investments, favourable demographics, digital transformation, and sustained policy reforms.

The Reserve Bank of India (RBI) has continued to pursue a balanced monetary policy approach aimed at maintaining price stability while supporting economic growth and financial stability. In its latest monetary policy review, the RBI maintained the policy repo rate at 5.25% and retained a neutral policy stance, reflecting confidence in the underlying strength of the Indian economy while remaining vigilant regarding inflationary and geopolitical risks.

The Government of India has sustained its focus on infrastructure-led development and fiscal consolidation. In the Union Budget 2025-26, capital expenditure was budgeted at approximately ₹11.2 lakh crore, continuing the Government's emphasis on creating high-quality infrastructure, improving logistics, enhancing connectivity, and crowding in private sector investment. The fiscal deficit has been targeted at 4.4% of GDP, reflecting the Government's commitment to balancing growth with fiscal prudence.

India's economic fundamentals remain robust, supported by healthy domestic demand, a well-capitalized banking system, expanding manufacturing capabilities, growing services exports, and strong foreign exchange reserves. While external risks such as geopolitical tensions, commodity price volatility, and global financial market uncertainties continue to pose challenges, India's medium-term growth outlook remains positive.

TEXTILE INDUSTRY

Global Textile Industry

The global textile industry continued to operate in a challenging environment during 2025, characterized by weak consumer demand, persistent geopolitical uncertainties, trade disruptions, and cautious inventory management across major markets. While the industry has shown signs of stabilization following the post-pandemic slowdown, recovery remains uneven across regions and segments of the textile value chain.

Global order intake declined for the fourth consecutive month through May 2025, reflecting cautious purchasing behaviour among international buyers. Europe and East Asia recorded the sharpest decline in orders, whereas Africa continued to report positive momentum. Nevertheless, global order backlogs improved modestly to approximately 2.3 months, and industry capacity utilization remained stable at around 72%, indicating gradual normalization of production activity.

Looking ahead, the global textile sector is expected to witness a gradual recovery driven by improving consumer sentiment, easing inflationary pressures, supply chain normalization, and increasing demand for value-added products, including technical textiles, performance fabrics, and sustainable textile solutions. Industry participants continue to focus on operational efficiency, digitalization, sustainability initiatives, and supply chain diversification to enhance competitiveness and resilience in an evolving global marketplace.

Indian Textile Industry

The Indian textile and apparel market is estimated to have reached approximately US\$ 235-240 billion during FY 2025-26, compared to around US\$ 165 billion in 2022. The industry is expected to maintain a healthy growth trajectory and is projected to reach approximately US\$ 350 billion by 2030, supported by expanding domestic consumption, growing technical textiles demand, and increasing integration into global supply chains.

India continues to be among the world's leading producers of cotton, man-made fibres, yarn, fabrics, garments, and technical textiles. The sector contributes nearly **2.3% to India's GDP**, about **13% of industrial production**, and provides direct and indirect employment to over **45 million people**, making it one of the country's most important industries.

The Government of India continued to strengthen the textile sector through a combination of policy reforms, infrastructure development, investment incentives, and export promotion measures aimed at enhancing India's competitiveness in the global textile value chain.

Five-Year Cotton Mission (2025–26)

In Union Budget 2025-26, the Government announced a dedicated Five-Year Cotton Mission with a focus on improving the productivity and quality of cotton, particularly Extra-Long Staple (ELS) Cotton, through advanced research, technology adoption, and improved farming practices. The initiative aims to reduce dependence on imports of premium cotton varieties, enhance raw material availability for the domestic textile industry, and support value-added textile and apparel manufacturing.

Expanded Budget for Textiles Ministry

Reflecting the Government's continued commitment to the textile sector, the allocation to the Ministry of Textiles was increased to approximately ₹5,272 crore in FY 2025-26, representing a significant increase over the previous year's allocation. The enhanced budgetary support is expected to accelerate sectoral development, promote innovation, strengthen infrastructure, and support employment generation across the textile value chain.

Technology Upgradation and Modernization

To encourage modernization and improve manufacturing efficiency, the Government has extended customs duty exemptions on select advanced textile machinery. Two additional categories of shuttle-less looms, namely Rapier Looms and Air-Jet Looms, have been granted full customs duty exemption, facilitating adoption of modern technology, improving productivity, and supporting the growth of technical textiles and high-value fabric manufacturing.

Custom Duty Adjustment (Knitted Fabrics)

Customs duty on select knitted fabrics has been raised shielding domestic producers from cheap imports and enhancing market competitiveness. Press Information Bureau.

PLI Scheme Effectiveness

The Production Linked Incentive (PLI) Scheme for Textiles continues to attract significant industry participation, particularly in the areas of Man-Made Fibre (MMF) apparel, MMF fabrics, and technical textiles. As of FY 2025-26, the scheme has facilitated investment commitments exceeding ₹7,300 crore, generated substantial production output, and contributed to export growth. The initiative is expected to strengthen India's position in high-value textile segments and create significant employment opportunities over the coming years.

PM MITRA Parks Expansion

The Government's flagship PM MITRA (Mega Integrated Textile Region and Apparel) Parks programme continues to progress across seven identified locations. These integrated textile parks are being developed with world-class infrastructure, plug-and-play facilities, common utilities, and multimodal connectivity. The initiative is expected to attract large-scale investments, reduce logistics costs, enhance economies of scale, and improve global competitiveness of the Indian textile industry.

Global Trade Outreach and Investment Drives

The Government continues to actively engage with global textile manufacturers and investors to promote India as a preferred textile manufacturing destination. Strategic collaborations with international partners, including Japan and other key markets, are being pursued to encourage investments in MMF, technical textiles, sustainable manufacturing, and advanced textile technologies. These initiatives are expected to strengthen India's integration into global supply chains and expand export opportunities.

OPPORTUNITIES AND GROWTH DRIVERS

- **PLI Schemes Expansion** – The Production Linked Incentive (PLI) schemes across sectors such as electronics, EVs, pharma, and textiles are expected to attract large-scale investments and create employment opportunities.
- **Union Budget 2025-26 Capital Expenditure Push** – The Government of India has continued its infrastructure-led growth strategy by allocating ₹11.21 lakh crore towards capital expenditure in Union Budget 2025-26, equivalent to approximately 3.1% of GDP. The sustained focus on public investment in roads, railways, logistics, urban infrastructure, energy, and digital connectivity is expected to stimulate private sector investment, strengthen economic activity, enhance productivity, and support long-term sustainable growth.
- **Digital Public Infrastructure (DPI)** – India's digital stack (UPI, Aadhaar, ONDC, Account Aggregator) continues to drive financial inclusion, boost e-commerce, and create efficiency gains across industries.
- **Green Energy Transition** – India's commitment to achieve 500 GW of non-fossil fuel capacity by 2030 and rapid expansion in solar, wind, and green hydrogen present significant opportunities in renewable energy and allied sectors.
- **'Make in India' and Manufacturing Push** – Policy support and ease-of-doing-business reforms are encouraging domestic manufacturing, positioning India as an alternative global supply chain hub.
- **Demographic Dividend** – With a young working population and rising urbanization, India offers a vast labour force and growing consumer demand that can sustain long-term growth.

THREATS

Global Economic Uncertainty – Slowing global growth and geopolitical tensions (Russia–Ukraine war, Middle East instability, US–China trade conflicts) could impact exports and investor sentiment.

Inflationary Pressures – Persistent food and fuel price volatility may keep inflation elevated, constraining RBI's monetary flexibility.

High Public Debt & Fiscal Constraints – Rising government borrowings and fiscal deficits may limit future policy support.

Climate & Environmental Risks – Increasing frequency of extreme weather events (floods, droughts, heatwaves) threatens agriculture, infrastructure, and energy security.

Global Trade Protectionism – Tariff hikes, export restrictions, and trade disputes pose risks to India's integration with global supply chains.

Skill Gap & Employment Challenges – Despite the demographic dividend, lack of adequate skilling and job creation could undermine long-term growth.

Financial Sector Vulnerabilities – Rising NPAs in some segments and exposure to global financial shocks could affect financial stability.

DISCUSSION ON FINANCIAL PERFORMANCE WITH RESPECT TO OPERATIONAL PERFORMANCE

The financial statements have been prepared in accordance with the requirements of the Companies Act, 2013 and applicable accounting standards issued by the Institute of Chartered Accountants of India. The details of the financial performance of the Company are appearing in the Balance Sheet, Profit & Loss Accounts and other financial statements forming part of this annual report.

INTERNAL CONTROL SYSTEM

Given the magnitude and nature of its business, the Company has maintained sound and commercial practice with an effective internal control system. The system ensures that all transactions are authorized, recorded and reported correctly to safeguard the assets of the Company and protect them from any loss due to unauthorized use or disposition. The adequate internal information system is in place to ensure proper information flow for the decision-making process. The Company also has well-established processes and clearly defined roles and responsibilities for people at various levels. The control mechanism also involves well documented policies, authorization guidelines commensurate with the level of responsibility and standard operating procedures specific to the respective businesses, adherence to which is strictly ensured. Internal audit is carried out frequently to create awareness and to take corrective actions on the respective units or areas, which need rectification. These reports are then reviewed by the management team and the Audit Committee for follow-up action.

HUMAN RESOURCE DEVELOPMENT

The Company regards its human resources as amongst its most valuable assets and proactively reviews policies and processes by creating a work environment that encourages initiative, provides challenges and opportunities and recognizes the performance and potential of its employees attracting and retaining the best manpower available by providing high degree of motivation. Your

Company believes in trust, transparency & teamwork to improve employees productivity at all levels.

NOTES TO ACCOUNTS

Note 1

A. CORPORATE INFORMATION

SHREE VIJAY INDUSTRIES LIMITED is a listed public company incorporated in India under the provisions of the Companies Act, 1956. The Company is not in operation as on 31.03.2026.

B. SIGNIFICANT ACCOUNTING POLICIES:

I. BASIS OF PREPARATION:

The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (IND AS) notified under Companies (Indian Accounting Standards) Rules, 2015. Financial statements for the year ended 31 March 2026 have been prepared in accordance with IND AS notified under the Companies (Indian Accounting Standard) Rules, 2015. The financial statements have been prepared on a historical cost basis.

The financial statements are presented in Indian Rupees ('INR') and all values are rounded to nearest Hundreds (INR 00), except when otherwise indicated.

II. CURRENT VERSUS NON-CURRENT CLASSIFICATION

The Company presents assets and liabilities in the balance sheet based on current/non-current classification. An asset is treated as current when it is:

- Expected to be realized or intended to be sold or consumed in normal operating cycle
- Held primarily for purpose of trading
- Expected to be realized within twelve months after the reporting period, or
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is current when:

- It is expected to be settled in normal operating cycle
- It is held primarily for purpose of trading
- It is due to be settled within twelve months after the reporting period, or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

The operating cycle is the time between the acquisition of assets for processing and their realization in cash and cash equivalents. The Company has identified twelve months as its operating cycle.

III. PROPERTY, PLANT AND EQUIPMENT

The company does not have any Property, Plant and Equipment during the year

IV. INTANGIBLE ASSETS

The company does not have any Intangible assets during the year

V. IMPAIRMENT OF NON- FINANCIAL ASSETS

The company does not have any Non- Financial Assets during the year.

VI. FINANCIAL INSTRUMENTS

The company does not have any Financial Instruments during the year.

(i) Financial liabilities:

Initial recognition and measurement

Financial liabilities are classified at initial recognition as financial liabilities at fair value through profit or loss, loans and borrowings, and payables, net of directly attributable transaction costs. The Company financial liabilities include loans and borrowings including bank overdraft, trade payable, trade

deposits, retention money, liabilities towards services, sales incentives and other payables.

The measurement of financial liabilities depends on their classification, as described below:

Trade Payables

The company does not have any trade Payables during the year.

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss. Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term.

Gains or losses on liabilities held for trading are recognised in the statement of profit and loss.

Financial liabilities designated upon initial recognition at fair value through profit or loss are designated as such at the initial date of recognition, and only if the criteria in IND AS 109 are satisfied. For liabilities designated as FVTPL, fair value gains/ losses attributable to changes in own credit risk are recognised in OCI. These gains/ loss are not subsequently transferred to profit and loss. However, the Company may transfer the cumulative gain or loss within equity. All other changes in fair value of such liability are recognised in the statement of profit or loss. The Company has not designated any financial liability as at fair value through profit and loss.

Loans and borrowings

Borrowings are initially recognised at fair value, net of transaction cost incurred. After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the EIR method. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the EIR amortization process. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs

that are an integral part of the EIR. The EIR amortization is included as finance costs in the statement of profit and loss.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit and loss.

Reclassification of financial assets:

The Company determines classification of financial assets and liabilities on initial recognition. After initial recognition, no reclassification is made for financial assets which are equity instruments and financial liabilities. For financial assets which are debt instruments, a reclassification is made only if there is a change in the business model for managing those assets. Changes to the business model are expected to be infrequent. The Company's senior management determines change in the business model as a result of external or internal changes which are significant to the Company's operations. Such changes are evident to external parties. A change in the business model occurs when the Company either begins or ceases to perform an activity that is significant to its operations. If the Company reclassifies financial assets, it applies the reclassification prospectively from the reclassification date which is the first day of the immediately next reporting period following the change in business model. The Company does not restate any previously recognised gains, losses (including impairment gains or losses) or interest.

VII. INVENTORIES

a) Basis of valuation:

- i) Inventories other than scrap materials are valued at lower of cost and net realizable value after providing cost of obsolescence, if any. However, materials

and other items held for use in the production of inventories are not written down below cost if the finished products in which they will be incorporated are expected to be sold at or above cost. The comparison of cost and net realizable value is made on an item-by-item basis.

ii) Inventory of scrap materials have been valued at net realizable value.

b) Method of Valuation:

- i) **Cost of raw materials** has been determined by using moving weighted average cost method and comprises all costs of purchase, duties, taxes (other than those subsequently recoverable from tax authorities) and all other costs incurred in bringing the inventories to their present location and condition.
- ii) **Cost of finished goods and work-in-progress** includes direct labour and an appropriate share of fixed and variable production overheads and excise duty as applicable. Fixed production overheads are allocated on the basis of normal capacity of production facilities. Cost is determined on moving weighted average basis.
- iii) **Cost of traded goods** has been determined by using First in First out (FIFO) method and comprises all costs of purchase, duties, taxes (other than those subsequently recoverable from tax authorities) and all other costs incurred in bringing the inventories to their present location and condition.
- iv) **Net realizable value** is the estimated selling price in the ordinary course of business, less estimated costs of completion and estimated costs necessary to make the sale.

VIII. TAXES

The company has no Tax expenses during the year for the year.

IX. REVENUE RECOGNITION

a) Sale of Goods

The Company recognizes revenue when control over the promised goods or services is transferred to the customer at an amount that reflects the consideration

to which the Company expects to be entitled in exchange for those goods or services.

Revenue is adjusted for variable consideration such as discounts, rebates, refunds, credits, price concessions, incentives, or other similar items in a contract when they are highly probable to be provided. The amount of revenue excludes any amount collected on behalf of third parties.

The Company recognises revenue generally at the point in time when the products are delivered to customer or when it is delivered to a carrier for export sale, which is when the control over product is transferred to the customer. In contracts where freight is arranged by the Company and recovered from the customers, the same is treated as a separate performance obligation and revenue is recognized when such freight services are rendered.

In revenue arrangements with multiple performance obligations, the Company accounts for individual products and services separately if they are distinct – i.e. if a product or service is separately identifiable from other items in the arrangement and if a customer can benefit from it. The consideration is allocated between separate products and services in the arrangement based on their stand-alone selling prices. Revenue from sale of by products are included in revenue.

X. EMPLOYEE BENEFITS

(i) Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within twelve months after the end of the period in which the employees render the related service are recognised in respect of employee service up to the end of the reporting period and are measured at the amount expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

XI. SEGMENT ACCOUNTING:

The company has only single segment of business. Hence segment accounting is not required.

XII. EARNINGS PER SHARE

Basic earnings per share are calculated by dividing the net profit or loss for the period attributable to equity shareholders by the weighted average number of equity shares outstanding during the period. The weighted average number of equity shares outstanding during the period is adjusted for events such as bonus issue, bonus element in a rights issue, share split, and reverse share split (consolidation of shares) that have changed the number of equity shares outstanding, without a corresponding change in resources.

For the purpose of calculating diluted earnings per share, the net profit or loss for the period attributable to equity shareholders and the weighted average number of shares outstanding during the period are adjusted for the effect of all potentially dilutive equity shares

XIII. BORROWING COSTS

Borrowing cost includes interest and other costs incurred in connection with the borrowing of funds and charged to Statement of Profit & Loss on the basis of effective interest rate.

Borrowing costs directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of the respective asset. All other borrowing costs are recognised as expense in the period in which they occur.

XIV. EXCEPTIONAL ITEMS

Exceptional items are transactions which due to their size or incidence are separately disclosed to enable a full understanding of the Company's financial performance. Items which may be considered exceptional are significant restructuring charges, gains or losses on disposal of investments of subsidiaries, associate and joint ventures and impairment losses/write down in the value of investment in subsidiaries, associates and joint ventures and significant disposal of fixed assets.

XV. CASH AND CASH EQUIVALENTS

Cash and cash equivalents in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to insignificant risk of changes in value.

XVI. PROVISIONS AND CONTINGENT LIABILITIES

Provisions

A provision is recognised when the Company has a present obligation (legal or constructive) as a result of past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Contingent liabilities

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the Company or a present obligation that is not recognised because it is not probable that an outflow of resources will be required to settle the obligation. A contingent liability also arises in extremely rare cases, where there is a liability that cannot be recognised because it cannot be measured reliably. The Company does not recognize a contingent liability but discloses its existence in the financial statements unless the probability of outflow of resources is remote.

Provisions, contingent liabilities, contingent assets and commitments are reviewed at each balance sheet date.

XVII. FAIR VALUE MEASUREMENT

The Company measures financial instruments at fair value at each balance sheet date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- (i) In the principal market for asset or liability, or

- (ii) In the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the Company.

The fair value of an asset or liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non- financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimizing the use of unobservable inputs.

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1- Quoted (unadjusted) market prices in active markets for identical assets or liabilities

Level 2- Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable

Level 3- Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorization (based on the lowest level input that is significant to fair value measurement as a whole) at the end of each reporting period.

For the purpose of fair value disclosures, the Company has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy as explained above.
